The Ritual is an autobiographical documentary exploring the commodification of the wedding ritual and how market demands map onto the bonds of friendship through the process of becoming a bridesmaid. Taking on multiple jobs to support their dream of becoming university professors, the film follows four women as they spend thousands of dollars each time a friend asks for their participation as a bridesmaid. The bridesmaid ritual functions as a kaleidoscope in which contemporary womanhood is filtered, solidified, negotiated, socialized and challenged. This documentary provides an alternative history of women's thoughts on the relational underbelly of the bridesmaid ritual, the comedy found in unexamined traditions, the often-unacknowledged joy of connections between women, and the contradictions that bind us all together.

Since 1993, over 430 young women have been found raped, tortured and murdered in the cities of Chihuahua and Juarez, Mexico. Over 600 women are still missing from the area without explanation from local or federal authorities. The circumstances of this atrocity, formally made visible by documentary filmmaker Lourdes Portillo in *Senorita Extraviada*, have evolved and exploded in the last 13 years. Once considered the maquiladora murders, this unthinkable phenomenon is more likely caused by a complex web of social, legal and political conditions exacerbated by negative media depictions of the abducted and missing women. This documentary explores the developing culture of violence towards women that allows injustice and oppression to continue.

In the Spring 2001, a pro-life exhibit was approved for display on the University of Texas campus. The 25-foot pictures of alleged fetuses were erected in a central location of the University grounds. The photographs accompanied written arguments that equated abortion with the genocide of Jewish people during World War II and sparked an intense controversy about free speech on University Campuses. In an attempt to hold a counter-demonstration, pro-choice groups on campus were restricted by force from exercising their free speech rights by university police. The film explores the fiery emotions resulting from exercising one of the most continuously controversial issues in the nation—free speech on university campuses.
